The company is using MPPEP funds to expand processing operations through the purchase of an existing structure to support expansion. This project has the support of local and state government, poultry farmers, food service distributors and community stakeholders.

The company is in a prime position to quickly expand production by utilizing this untapped capacity, and can expand production without having to expand harvest capacity or build a new harvest facility. The objectives of this project are: 1) Utilize existing capacity to harvest additional hogs daily, 2) Provide ethnic consumers with value-added pork products (consumers not normally targeted and served by major Midwestern meat processors) and 3) Provide additional jobs to the local community (a community that suffers from both high levels of unemployment and high levels of poverty).

Our USDA-MPPEP proposal is to support core projects that directly target our current bottlenecks, allowing us to expand our capacity by over 50% and create dozens of new jobs and millions of dollars in premium revenue for independent livestock producers.

The project will double slaughter capacity and more than double processing capacity over the next 3-5 years, allowing the company to offer more local farms and small businesses a better choice in processing options beyond the traditional players. The processing plant located in Grand Rapids, recently underwent an expansion that automated slaughter and deboning processes. The improvements are needed to further support the expansion. Prior to the expansion Michigan Turkey Producers Cooperative had the capacity to process 5.3 million turkeys annually. Following the expansion and the utility upgrades made possible with the grant, they will have the capacity, with an additional shift, to process almost 10 million turkeys per year. The additional capacity will allow the plant to be back-up for other slaughter plants of similar size in neighboring states should the need arise.

The new facility will include processing plant; barn and cold storage space, and retail space. The company projects to increase processing by 50 percent by May 2026.

IFS is an approved commodity processor and at least 80 percent of the company's protein business is USDA donated chicken. The majority of the public-school children IFS serves are economically disadvantaged and under free and reduced school lunches. IFS currently sells approximately 15 million pounds of poultry products annually, all of which are co-manufactured. During the pandemic, IFS experienced poultry supply delays and disruptions which frustrated fulfilling customer commitments.
SC	Lindsey Graham Tim Scott	Ralph Norman (05)	Prestage Farms of South Carolina LLC	\$24,951,753	This Rural Development investment will be used to help offset the costs associated with purchase of equipment and associated operating expenses. Prestage Farms of South Carolina LLC, a family owned and operated company in business since the early 1980s, has constructed a technologically advanced poultry processing plant with enhanced vertical integration within the company. Using European air-chilled technology the plant will process turkey with increased sanitation and longer shelf life compared with traditional processing plants. The plant will be highly automated and more efficient than a traditional turkey processing operation, creating a significant increase in output. The facility located in Kershaw County is expected to process 8,000,000 birds per year and will create 292 new full-time jobs.
