**ORDER GRANTING PETITIONER'S MOTION
TO WITHDRAW PETITION FOR APPEAL TO JUDICIAL OFFICER**

This is a proceeding under the Food and Nutrition Act of 2008 (7 U.S.C. §§ 2011 *et seq.*).

The case was initiated on July 9, 2018 by the State of Vermont, Department for Children and Families ("Petitioner"¹), with a Notice of Appeal "of the assignment of a payment error rate for federal fiscal year 2017 by the United States Department of Agriculture, Food and Nutrition Service" ("Respondent").²

On June 18, 2019, Chief Administrative Law Judge Channing D. Strother entered a Decision and Order dismissing the case for lack of subject-matter jurisdiction.³ On July 18, 2019,

Petitioner filed a "Petition for Appeal to Judicial Officer to Reverse Decision and Order Dismissing Case and Remand for a Decision on the Merits."


On August 5, 2019, Petitioner filed a motion "request[ing] that DCF's petition for appeal to the Judicial Officer in the above-captioned case, filed on July 18, 2019, be withdrawn."⁴

ORDER

Petitioner's Motion to Withdraw Petition for Appeal to the Judicial Officer is hereby GRANTED.
