) AND ORDER

This proceeding was instituted under the Horse Protection Act, as amended (15 U.S.C. § 1821 et seq.)(HPA or Act), by a complaint filed by the Administrator of the Animal and Plant Health Inspection Service, United States Department of Agriculture (APHIS), on December 29, 2016, alleging that the respondent violated the Act. This decision is entered pursuant to the consent decision provisions of the Rules of Practice applicable to these proceedings (7 C.F.R. § 1.138).

Respondent Kenny Lawrence admits the jurisdictional allegations in the complaint and specifically admits that the Secretary has jurisdiction in this matter, neither admits nor denies the remaining allegations, waives oral hearing and further procedure, and consents and agrees to the entry of this decision, for the purpose of settling this proceeding. The complainant agrees to the entry of this decision.

Findings of Fact

Kenny Lawrence is an individual whose business mailing address is Post Office Box 2471, Shelbyville, Tennessee 37162. At all times mentioned herein, Mr. Lawrence was a "person" and an "exhibitor," as those terms are defined in the regulations issued pursuant to the Act (9 C.F.R. § 11.1 et seq.)(Regulations).

Conclusions of Law

The respondent has admitted the findings of fact set forth above and the parties have agreed

to the entry of this decision. Therefore, such decision will be entered.

Order

Respondent is disqualified for one year, beginning February 15, 2017, 2017, and ending February 14, 2018, from showing, exhibiting, or entering any horse, directly or indirectly through any agent, employee, or other device, and from judging, managing or otherwise participating in any horse show, horse exhibition, or horse sale or auction, directly or indirectly through any agent, employee, or other device.<sup>1</sup>

The provisions of this order shall become effective immediately. Copies of this decision shall be served upon the parties.
