

The Office of Tribal Relations (OTR) team works in collaboration with Mission Areas and agencies within USDA, other federal agencies, tribal governments, and other tribal stakeholders to promote equity in all facets. This is particularly important when it comes to Indian Country due to systemic inequities that have occurred over centuries that still reverberate today. We look forward to engaging with tribal nations at the Tribal Self-Governance Conference in Tulsa and participating in the FDPIR Tribal Leader Consultation Work Group Consultation and Commodity Supplemental Food Program Consultation.

The [upcoming tribal consultations](#) allow OTR to facilitate engagement and learn how to best align our policies and programs to address tribal barriers and access to USDA programs. For example, the [Rural Business Development Grant proposed rule](#) recognizes a shift in response to past consultation. The consultation and listening session scheduled on July 12 is our opportunity to engage tribal leaders to ensure we are on the right path to recognizing tribal government entities as eligible beneficiaries in our programs like the Rural Business Development Grant.

The Office of Tribal Relations administers the Tribal Fellowship Program. [USDA welcomed the Tribal College Fellows](#) to the Washington, D.C. office to meet USDA program leaders and to learn more about USDA programs and services. OTR will continue to work with the Tribal College Fellows throughout the year to strengthen our relationship with the tribal colleges serving Indigenous students and communities.

**Description:** A hazard mitigation plan can be a road map to resilience. Tribal nations can use them to plan for and reduce the risk of natural disasters. In addition, a FEMA-approved mitigation plan is a condition for receiving certain types of non-emergency disaster assistance, including funding for mitigation projects. This webinar is for tribal government officials, planners, and anyone involved in tribal mitigation planning. FEMA will cover basic mitigation planning concepts, types of mitigation plans, steps to create a mitigation plan and available resources. Later this year, FEMA will begin the update process for its tribal mitigation planning policy. This webinar is a primer for upcoming

engagement with tribal nations related to the policy update. Note that this webinar will be recorded.

#### **[Calendar Year 2022 Disaster Water Grants](#) – Application Deadline: Rolling Until Funds Exhausted**

The CY 2022 Disaster Water Grants Program is designed to assist communities by awarding grant funds to qualified entities for expenses related to water infrastructure systems in designated areas that were impacted by events that occurred during CY 2022 and were recognized through Presidentially Declared Disasters. In addition to damage repairs, these grants are also intended to develop system capacity and resiliency in order

to reduce or eliminate long-term risks from future events. Water infrastructure systems include drinking water, wastewater, solid waste, and stormwater projects serving eligible communities. Adequate documentation must be provided to demonstrate impacts to the water infrastructure systems.

**[Consolidated Multifamily Housing Technical Assistance Grant Programs](#)** –

Application Deadline: July 3, 2023

The Rural Housing Service (RHS) announces the availability of funding for Multifamily Housing Nonprofit Transfer Technical Assistance (MFH NP TA) Grants and Off-Farm Labor Housing Technical Assistance (Off-FLH TA) Grants. This funding is available for eligible technical assistance (TA) providers seeking grants to provide technical assistance services to qualified applicants.

**[FY2023 Scientific Cooperation Research Program](#)** – Application Deadline: July 7, 2023

USDA's FAS administers the SCR. This program has historically supported up to 10 collaborative research programs annually. All applications must include foreign collaborations, and projects should not exceed two years. Funding may be allocated to foreign collaborators through subawards.

**[FY23 Cochran Fellowship](#)** – Application Deadline: July 31, 2023

The U.S. Department of Agriculture, Foreign Agricultural Service (FAS), Fellowship Programs, announces this funding opportunity to support the Cochran Fellowship Program (CFP) by issuing new awards. This opportunity is available to Minority Serving Institutions (refer to Section C). This program is intended to support improved understanding of the principles of urban agriculture among program participants. The objective of this program is to educate Fellows on best practices within urban agriculture, including community building to increase global food security. The goal of this program is to increase these countries' capacity for agricultural research, extension, and participation in international trade.

**[Organic Market Development Grants](#)** – Application Deadline: August 8, 2023

This program will support the development of new and expanded organic markets by providing additional resources for businesses transitioning to organic or initiating new organic production and processing capacity.

**[FY23 School Foodservice Workforce](#)** – Application Deadline: August 21, 2023

This Request for Applications (RFA) announces the availability of funds for a cooperative agreement. This funding opportunity will support research projects to better understand and generate information related to the school foodservice workforce focused on dimensions such as worker satisfaction, workforce experience, and training and development. Relevant research activities may include, but are not limited to providing information on career pathways for the school foodservice workforce, including training and skill-building opportunities, promotion potential, and tenure/retention within individual employers and the industry as a whole; identifying skills used on the job by role, including analysis of transferability of skills to other industries; identifying level of worker satisfaction and describe workplace conditions (perception and objective measures); and examining how any of the above vary across roles, demographics, school/school food authority (SFA) characteristics, and geography.

**[FY23 Review of Produce Safety University](#)** – Application Deadline: August 21, 2023

The purpose of the Review of the Produce Safety University Cooperative Agreement is to select one organization to evaluate the Produce Safety University (PSU) course

developed by USDA Food and Nutrition Service (FNS) in collaboration with USDA Agricultural Marketing Service (AMS). PSU is a week-long train-the-trainer immersion course that is typically held five times each year in the late spring and summer months. The course immerses child nutrition professionals in the fresh produce supply chain. Participants learn to identify and manage food safety risks associated with fresh produce whether it's purchased from farmers or distributors, received whole or fresh-cut, or grown in a school garden. The curriculum covers all aspects of the fresh produce supply chain from growing and harvesting to storage and preparation through a combination of lecture, laboratory, and field-trip instruction.

FNS seeks to enter into a cooperative agreement for up to \$600,000.00 with a selected applicant capable of evaluating the PSU course, the effectiveness of its curriculum, and determining the impact of PSU graduates. Eligible entities include public and state controlled institutions of higher education; private institutions of higher education; and nonprofits having a 501(c)(3) status with the Internal Revenue Service (IRS), other than institutions of higher education; all non-profit organizations must include their 501(c)(3) determination letter issued by the Internal Revenue Service (IRS). To be eligible, the entities stated above must demonstrate successful completion of rigorous research through publication of research in peer-reviewed journals.

**[Agriculture and Food Research Initiative \(AFRI\) Competitive Grants Program Foundational and Applied Science Program](#)** – Application Deadline: December 29, 2023

The AFRI Foundational and Applied Science Program supports grants in six AFRI priority areas to advance knowledge in both fundamental and applied sciences important to agriculture. The six priority areas are: Plant Health and Production and Plant Products; Animal Health and Production and Animal Products; Food Safety, Nutrition, and Health; Bioenergy, Natural Resources, and Environment; Agriculture Systems and Technology; and Agriculture Economics and Rural Communities. Research-only, extension-only, and integrated research, education and/or extension projects are solicited in this Request for Applications (RFA).
